Unfinished Business:

- Land Donation—Anya Mayo in active negotiation
- Water Softener System—currently two bids—need analysis of the two bids to find which equipment is the most promising

New Business:

- Hand carved and constructed bench donation from John Hoenselaar, honoring VFFs who
 responded to his own medical emergency, was discussed. Once it is delivered, we can find a
 place on the island to display it; the park and stage were suggested as possible locations. After
 delivery, a thank you letter will be sent to John.
- A motion was made to express heartfelt thanks to the fire department and fire fighters for their hard work after the last wind storm, removing several downed trees, plus protecting the public from downed powerlines. Motion seconded; motion passed unanimously.
- Fire Levy lid lift. Gerry presented figures and percentages from our previous levy in 2009. (See attached info he presented.) Gerry emphasized we need to come up with justification for the lid lift. Property values have increased dramatically since 2009, yet our levy has dropped from \$.50 cents per \$1,000 to \$.31 cents in that time. Resolutions need to be written, and research with Skagit County Auditor needs to be done to inquire about the mechanism needed to get a proposition for levy lid lift onto the ballot in the spring, as well as a build levy for a new fire station. Commissioner Wertheimer volunteered to contact the Auditor and will report on next steps at our December meeting.

Meeting adjourned at 8:00 pm. The next regular meeting will be Monday, December 11, 2023 at 7:00 pm.
